**Dermatology comes to Kaiser Permanente Mill Valley**

**SAN RAFAEL, Calif. July 7, 2009** – Kaiser Permanente is moving its Downtown San Rafael dermatology services to the Mill Valley Medical Offices beginning July 6.

“This is an opportunity for us to better serve our members in southern Marin,” said Dr. John Maddox, chief of Kaiser Permanente San Rafael Dermatology department. Due to the high demand for our dermatology services, we are thrilled to bring our physicians to this convenient location and provide better access for our members in Southern Marin.”

The primary practice for Kaiser Permanente dermatologist, Dr. Nancy Todes-Taylor, will now be located in Mill Valley. She will continue to provide Mohs services, a specialized procedure for treating skin cancer, at the San Rafael Medical Center, as well as dermatology services at the Petaluma Medical Office Building.

In addition, many of the San Rafael Medical Center’s other excellent dermatologists will provide skin care at the Mill Valley office.

The Kaiser Permanente Mill Valley office first opened in 2006 with pediatricians Drs. Richard Dow and Michael Harris. As part of Kaiser Permanente’s commitment to our members “total health”, the Mill Valley pediatrics department is merging with our offices in San Rafael and Novato. Dr. Dow will practice at the San Rafael Medical Center in Terra Linda and Dr. Harris will see patients at the Petaluma and Novato Medical Offices.

With the addition of dermatology at the Mill Valley office, laboratory services will no longer be available. Members can have their blood drawn at either the Kaiser Permanente San Rafael Downtown location, at 3rd and A streets, or at the main San Rafael Medical Center in Terra Linda.
